

NCRS Board of Directors meeting was called to order at 11:00 AM EST

 - ii.Registration cost is increasing from \$70 to \$90.

 - John Tidwell cautioned the Board about the perils of having cars on road tours without registration and insurance data on file.
 - a. Liability insurers may not pay for incidents if data is not on file.
 - 2. The Board made it clear that registration and insurance data <u>must</u> be on file or cars will not be allowed to attend.

 - 2. Discussion of the challenges in changing the program name.
 - 3. Shannon Urton noted that historically, we are entering our fourth year of considering a potential name change.
 - a. The Board has dedicated time, energy, committee time, and resources to advancing the program.
 - 4. Shannon Urton moved, and Patricia Kropac seconded, to change the Concours program name to "Modified Corvette Class" with "Stock" and "Custom" divisions.
 - a. Discussion:
 - i. Mark Tulley wants to review the potential effects of the name change.

- ii. Dave Brigham feels strongly that the Judging Office should be separate from the Board and thus should be solely in charge of naming and operating the program.
 - 1. Vinnie Peters strongly supported Dave Brigham's position.
- b. Failed: 4 For (Hillhouse, Kropac, Murray, Urton), 5 Against (Ballard, Ingham, Johansen, Ledgerwood, Tulley), None Abstained.

c. Administrative Access and IT Build Update - Shannon Urton.

- i. Shannon Urton made the following statement:
 - 1. "I would like to thank John, Rob, Gary and Sherri for their due diligence to find a workable solution to our problem of access control.
 - 2. Their investigation brought to light many additional concerns for our IT infrastructure and security. Sherri's security review "efforts to protect NCRS" has been exemplary by volunteers and those working part-time. Needed to "further strengthen the security posture of the NCRS".
 - 3. Some chapter sites not encrypted or lack up-to-date SSL (secure socket layers) certification (6 of 48) websites.
 - 4. Password protocol and two-factor identification.
 - 5. Written proposal from IT regarding its' steering committee is not consistent with our committee structure.
 - For the IT collective to submit for approval of what is required of this BoD to decide upon cannot be honored as presented".
 - 7. Shannon recommended formation of an IT Steering Committee with the following members:
 - a. Mark Tulley, Patricia Kropac, John Tidwell, John Waggoner, Shannon Urton.
 - 8. Purpose of the committee will be to bring recommendations on IT issues to the Board of Directors.
 - A recommendation will be made by the IT Steering Committee to the Board of Directors regarding IT access for all roles.
 - 9. Consensus of the Board to implement the IT Steering Committee

d. NCRS Marketing Infrastructure - Shannon Urton.

- i. US Digital Partners revisit from October:
 - 1. Similar presentations to the Board were made in early 2018 from Canyon Creative and Floyd & Partners.
 - a. \$30k-50k range.
 - b. The Board did not think that the proposed expenditures were worth it as it was perceived more as a marketing campaign from Floyd & Partners.
 - 2. Today it is more about infrastructure and IT security for the future rather than marketing.

- 3. Our strategic and action plan intent was to investigate and implement plans moving forward in 2023.
- 4. Why make this capital investment?
 - a. Website is what every potential member sees of us first, it is our "cornerstone".
 - b. Keep and retain members.
 - c. Stand out in the Corvette crowd.
 - d. Less than ideal design hurts search rankings.
 - e. UX focus is the industry standard.
 - f. We are way overdue.
- e. National Town Hall Membership Meeting Shannon Urton.
 - i. Will review and discuss the strategic and action plans.
- f. NCRS National Gallery Shannon Urton.
 - i. Will be held at French Lick in 2023.
